



eGrainSM System Tariff

Electronic Warehouse Receipt Application

Terms and Conditions

Effective March 23, 2009

The fees, terms and conditions noted in this tariff are to be considered a part of the agreement between eGrain, Inc. and users of the Electronic Warehouse Receipt (EWR) Application (“system”). The fees, terms and conditions of this tariff are subject to review by eGrain, Inc. annually. A new tariff will become effective on June 1st of each year and will remain in effect for the next 12 months. The new tariff will apply to new subscribers and to current subscribers who renew their subscription during that 12-month time period.

Fees

1. Grain and Rice Warehouses

Annual fees are based on a company’s total Licensed Capacity in bushels. All grain warehouses with the exception of rice warehouses will be discounted by 25% until the USDA allows EWRs to be used for USDA – Price Support loans.

Annual subscription fees cover the costs of developing, operating, maintaining, updating, storing EWRs electronically for six years*, providing customer services, authenticating registrants, securing, insuring, patenting, the system as well as maintaining approved provider status with regulatory authorities including USDA annual fees.

*NOTE - Electronic warehouse receipts are required to be electronically stored by the provider for six years after December 31st of the year the receipt was canceled.

EWR Pricing for Warehouses Above (Option 1)

- EWRs are priced individually at \$2.00 per EWR and paid for in advance.
- EWRs shall be purchased by issuer in increments of 100.
- Issuer may use EWRs for any of their warehouse locations in which the state or USDA accepts EWRs
- EWRs not used during the year purchased are not lost and may be used in subsequent years.
- Unused EWRs at the end of a subscription year will carry over to the following year and be available for future use.
- There are no reimbursements for unused EWRs when an account becomes inactive.

2. Grain and Rice Warehouses with Minimal Warehouse Receipt Use

- This tariff is for grain and rice warehouses that do not issue many warehouse receipts in a given year. The annual fee for companies that fall into this category is \$200.00 per year.
- The registration and profile approval process is the same as for large EWR issuers.
- This pricing option is only available to warehouses that have a licensed capacity under 9 million bushels.

EWR Pricing for Option 2

- EWRs are priced individually at \$10.00 per EWR and must be ordered in increments of 5 (five).

3. Producers

- Producers are not charged a subscription fee to use the system.

4. Banks / Lending Institutions and Processors

- Banks and other lenders using electronic warehouse receipts for collateral purposes, along with processors and millers are charged an annual subscription fee of \$350.00.

5. USDA – FSA - Price Support Division (National, State and County Offices)

- These rates will be negotiated annually with the USDA - Price Support Division.

6. Licensing Authorities (Federal and State)

- As stipulated in the USDA provider agreement, there is no fee for USDA or State licensing authorities to access the system.

7. Futures Commission Merchants, Pool Marketers

- There is a \$100 annual subscription fee.

8. Boards of Trade / Grain Exchanges

- These users are charged an annual subscription fee of \$1,000. Fees for enhancements requested by these entities will be negotiated on a case-by-case basis.

9. Special Reports and Services

- Special reports and services may be provided to users upon request and the fee for such service will be negotiated on an individual basis.

Training and Assistance

The system is designed to be user friendly and extensive training should not be required. Detailed instructions for each type of transaction are provided within the system, to guide users. For subscribers with multiple users or multiple locations who request on-site training sessions, the fee for additional on-site training will be negotiated on a case-by-case basis.

Special Service Requests / Fees

Subscribers may request additional services and if eGrain, Inc. agrees to provide those additional services, a separate fee will be negotiated based on the nature of the request.

Information Requests From Non-Subscribers / Subpoenas

In the event that eGrain, Inc. receives a written request or subpoena for Electronic Warehouse Receipt information from a non-subscriber, affected subscriber(s) will receive notification from eGrain, Inc. of such a request and will have 7 days to take appropriate legal action to prevent eGrain, Inc. from disclosing information to the requesting party.
